Achievements and performance

Summary of the main achievements of the charity during the year

The Memorial Hall continues to play an important role in the life of Elsenham and surrounding Villages, with Groups meeting on every day of the week..

We continue to produce the Village Magazine "Elsenham News" which is produced by volunteers and delivered free to each household in the village each month (except January). Due to increased costs in the maintenance of printing machinery, a decision was taken in 2015 to pay a commercial printer to print Elsenham News, although we retain full editorial control. Elsenham News intends to remain fully funded by advertising receipts.

In 2015 we developed the Elsenham Community Association (ECA) website, which, in conjunction with Elsenham News, is the repository of the Village Diary of Events.

During 2015 we paid to have the Memorial Hall professionally redecorated and installed new covers to protect users from excessive heat from storage heaters. We obtained 50% grant funding from Uttlesford District Council for this expenditure.

We have continued to be supported by our District Councillors who have used funds at their discretion to support the ECA and Village Fete. The Village Fete and Craft Fair and Village Santa continue to be run for the benefit of the Village and proceeds are donated to the ECA.
